


Capital and Business Partnership with MIRAI-LABO

- Accelerating development of battery logistics platform -

SENKO Group Holdings Co., Ltd. (Head office, Koto-ku, Tokyo; President, Yasuhisa Fukuda; "SENKO Group") set up a capital and business partnership on January 27 with MIRAI-LABO Co., Ltd. (Head office, Hachioji, Tokyo; President, Toshio Hiratsuka; "MIRAI-LABO"), a company developing environmental platforms such as solar panel roads and reused EV batteries.

MIRAI-LABO develops a broad range of environmentally friendly products based on solar panel road power generation technology, battery technology, and energy efficiency lighting technology in line with its environmentalist corporate philosophy, and is also involved in deterioration diagnosis of used EV batteries and development of reused products. As a developer of environmental platforms, MIRAI-LABO will coordinate efforts as a business partner while contributing to efforts to build a sustainable global environment with a view 100 years into the future.

Since last year, the SENKO Group has concentrated efforts toward developing a logistics platform for the production, sales and recycling of batteries used with electric vehicles and solar power generation. It has concluded a capital and business partnership with MIRAI-LABO with the aim of
