

## Notification Regarding Transfer OG Sports Co., Ltd. Stocks

Osaka Gas Co., Ltd. (President, Masataka Fujiwara; “Osaka Gas”) and SENKO Group Holdings Co., Ltd. (President, Yasuhisa Fukuda; “SENKO”) have agreed to transfer to SENKO all stocks of Osaka Gas’ 100% subsidiary OG Sports Co., Ltd. (President, Koji Kato; “OG Sports”) effective July 1, 2022.

Since it was established in 1981, OG Sports has operated directly managed fitness clubs, swimming schools and tennis clubs under the brand names ‘COSPA,’ ‘FITBASE 24’ and ‘30peak’ as well as exercise facilities consigned by local governments. As of April 2022, OG Sports manages 62 facilities mainly in the Kansai region, and also operates health care businesses that is supported by countless customers.

Osaka-based SENKO is one of the largest domestic logistics companies in the group, and in addition to its logistics business is also expanding its living support business in the fields of health, lifestyle and foods. Its 100% subsidiary BLUE EARTH JAPAN provides lifestyle-related services in the nursing, nursing home, childcare, housework, and restaurant segments, and currently operates fitness businesses with twenty facilities in Yamanashi Prefecture and Tokyo.

With Osaka Gas revising its business portfolio in line with the Daigas Group Medium-term Management Plan, the optimum approach has been determined to be placing a greater focus on the living support business with the aim of creating further growth for OG Sports, with operations fully supported by SENKO and its track record in the fitness segment.

By incorporating OG Sports into the group, SENKO aims to expand regions it operates its fitness business in and also develop new services coordinated with its nursing business. Expanding business in the health-related sector will drive further growth in the living support business that supports people in their daily lives.

As a central company in SENKO's living support business, OG Sports will be able to harness SENKO's management resources and know-how to target further growth.
